- (iii) sign the Contract Agreement within **9 (Nine) calendar days** of issuance of this NoA but **no later than 16.01.2024 (Thursday)**.

You may also please note that, this Notification of Award (NoA) will constitute the formation of this Contract which shall become binding upon you.
